Based on his experience with the road sector, Michel Démarre will call to mind that in the long term, procurement procedures can impact the structure of the construction industry. It is therefore relevant to study how procurement procedures could help in developing the private construction sector in Africa. In particular, long-term performance-based road maintenance contracts could help in this respect and contribute to set up a local industry and train their staff, while contributing effectively to road maintenance, provided certain conditions are met, which will be discussed in his presentation.
